#### **Casting Requirements**



Mechanical - General	
	In addition to the Certificate of Conformance minimum requirements listed in RL-SR-O01 Supplier Quality Manual, supplier shall include the following:
	Casting serial number
	<ul> <li>Fixed Foundry Process/Document number and revision date</li> <li>Statement of no weld repair, if applicable</li> </ul>
	Weld repair map(s), if applicable
	Supplier shall generate a weld map that details the location, size, and depth of the welds when a weld repair is performed on a casting. This also applies to any autogenous welds performed.
Clause	<ul> <li>Weld maps shall be stored at supplier's facility per the requirements listed in RL-SR-001 Supplier Quality Manual and be available for review upon request from Rocket Lab.</li> </ul>
	<ul> <li>If no weld repairs were performed, supplier shall indicate this on the Certificate of Conformance. No weld maps are required from supplier if there were no weld repairs performed.</li> </ul>
	Supplier shall submit certificates of heat treat records for all heat treatment processes performed for the casting.
	Supplier shall provide all mechanical test results with every part(s) shipment to Rocket Lab.
	Supplier shall clean parts of any and all background penetrant following penetrant non-destructive testing inspection and prior to shipment to Rocket Lab.
